

## **Terms and Conditions**

Your use of [www.wedoyouressay.com](http://www.wedoyouressay.com), hereinafter referred to as the Website, including your placement of orders at WeDoYourEssay.com, hereinafter referred to as the Company, constitute your agreement with the terms and conditions stated below. If you disagree with any of these terms and conditions, you are free to leave this Website.

It is your obligation to read and understand this Terms and Conditions before browsing through the website, registering, and proceeding with your order placement.

### **General Website Use Policy**

Complying with this Website Usage Policy grants you personal, non-exclusive, non-transferable, limited privilege to enter and use the Website.

You must not use this website in any way that causes, or may cause, damage to the website or impairment of the availability or accessibility of the website; or in any way that is unlawful, illegal, fraudulent or harmful, or in connection with any unlawful, illegal, fraudulent or harmful purpose or activity.

You must not conduct any systematic or automated data collection activities (including without limitation scraping, data mining, data extraction and data harvesting) on or in relation to this Website.

### **User Information and Privacy**

When you decided to register and/or place an order, you agree to fill an online form requiring you to provide certain personal information. Please be aware that all customers, especially new ones, are required to register to the website in order to place an order.

Information provided by the user, for the purposes of registration and order placement automatically becomes the property of the Company. ### **Order Placement and Use of Services**

## **Delivery of Completed Product**

Upon completion, a Product is available for download by the Customer in his personal account panel on the Website.

If a Customer does not receive a completed Product by the deadline, he may request for a refund. The Company will not be liable for any delays or technical problems in the delivery of the Product resulting from any malfunction of the customer's mail-server or the customer's Internet Service Provider.

Please note that the Client will have 7 days upon receiving the Product to request for a revision. The paper (or its part) will be approved automatically after the end of the approval period, which is calculated from the moment the last version was uploaded to your personal account and according to the deadline.

After downloading your paper, the Customer will receive an email with an invitation to fill out a survey in his personal control panel. There, the Customer will be asked to assess the quality of the paper received, work of the writer and Customer Support Representatives. This will help the Company monitor the quality better and improve its service every day.

## **Revision and Refund Policy**

You are entitled to request for revisions if and only if the product received contains discrepancies anytime within the period of seven (7) days after the deadline of the first draft. Notable examples of discrepancies are failure to follow your order specifications; or cases of plagiarism in which the product registers substantial plagiarism level of 20 percent—not including in-text citations, reference lists, clichéd phrases, or required inclusion of block quotations or verbatim transposition/copy-typing.

The deadline for you to receive your revised product will be based on an agreed time and date. Remember that the deadline varies according to the extent of revision request and of course, to the quantity specification, i.e., number of pages. The submission deadline begins anew with each new revision request. Remember, again, that qualified revision request should only be made within the period of seven (7) days after the deadline of the first draft.

You may not, under any circumstances, cancel an order that has already been paid.

The company cannot make a refund for canceled orders simply because the products can easily be duplicated.

The only refund or money back guarantees offered by the Company are limited to (1) a missed deadline due to internal fault and not to failures in your part; or (2) failure to complete your order due to workforce shortage. However, due to lengthy transactional processes involving refund, the Company strongly advises you to opt instead for a crediting system. This means that instead of

refunding, your payment will be credited to your account. You can use this credit next time you decided to place an order again.
